### Invasives 101

Sharon Plumb, *Invasive Species Coordinator at The Vermont Chapter of the Nature Conservancy*

Learn how to identify invasive plant species, how they spread, and why they are a threat to biodiversity.

Sharon provides technical assistance to landowners, is co-chair of the Vermont Invasive Exotic Plant Committee, works closely with the horticultural industry, and manages the Wise on Weeds! public outreach program. She grew up in Vermont and is convinced that with concerted, coordinated effort it is possible to manage invasive plants so that Vermont's fields and forests remain truly Vermont. She has a B.S. and an M.S. in Natural Resources Planning from the University of Vermont.

### Invasives at the Landscape Level

Nathan Fice, *Bennington County Forester*

Nate will speak about the impacts of invasive species at the landscape level and the problems that large landowners face when making forest management decisions. He and Chris Polatin will discuss setting priorities and ways to plan for success in reaching your forest management goals.

Nate has worked for the Vermont Department of Forests, Parks, & Recreation for over 20 years. His career has included a variety of experiences from managing state forest lands to fighting forest fires to promoting forest steward-

ship with private landowners. As co-founder of the Bennington County Sustainable Forest Consortium, Nate is excited about bringing people together to learn about our natural resources and to share their experiences working with the land.

### Treatment tools and techniques

Chris Polatin, *owner, Polatin Ecological Services, LLC*

Chris will demonstrate various tools, techniques and timing sequences that he has used to successfully control invasive plants common in the southern Vermont region. Emphasis will be on integrated vegetation management which includes both mechanical and chemical approaches. Non-chemical alternatives will also be discussed. Chris will also join Nate Fice in discussing setting priorities for treatment and for achieving management goals.

Chris is as a habitat restoration specialist. He regularly performs all aspects of invasive plant management including planning, mapping, monitoring and implementing various control activities. He holds a MS in conservation biology and has worked as an environmental professional for more than a decade.

### Integrating invasives control with other management objectives

Alan Calfee, *owner, Calfee Woodland Management LLC*

Alan will share his practical experi-

ence in the development of strategies to control problematic invasive plants as a part of the overall management plan for a woodlot. Alan, the forester for Hildene, will demonstrate some of the techniques used to encourage native regeneration and discourage invasives on the property as part of forest management activities.

Alan is a landowner and professional forester who has been practicing forestry in southern Vermont for over 20 years. In addition to helping private woodland owners manage their properties with a holistic and sustainable approach, Alan has taught at the college level and worked extensively with the Forest Stewardship Council (FSC) forest management certification in the northeast region of the U.S. and other countries. He has a passion for hands on management of the land and forests and enjoys sharing that with others.

From the south, at the Stewart's in Arlington, go north 7.4 miles on Rt. 7A to the entrance to Hildene on the right. Park at the Hildene Visitor's Center.
